1. ANNOUNCEMENT:


The Blacktown Mini Bike Club, hereafter called the PROMOTER, will conduct the 2015 Minikhana State Titles for Junior, Senior and Demonstration class motorcycles at the Ian Packer Junior Training Facility, on Saturday 24th and Sunday 25th October 2015.

2. JURISDICTION:

- 2.1. The above-mentioned meeting has been authorised by Motorcycling NSW Limited who has issued the Motorcycling Australia Permit Number 5/15/61509 and is open to holders of current Motorcycling Australia National Competition Licenses.
- 2.2. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, the By-Laws of Motorcycling NSW and any final instructions.
- 2.3. BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. <u>ENTRIES:</u>

- 3.1. Entries open forthwith and mail entries close Friday 16th October 2015 and email entries close midnight Tuesday 20th October 2015.
- 3.2. Entries can only be via mail and email. An online entry process is not be available for this event.
- 3.3. Entry forms should be fully completed including licence details, signed by both parent and rider, clearly scanned and then emailed to <u>racesecretary@yahoo.com</u>
- 3.4. The DEED OF APPOINTMENT OF TEMPORARY GUARDIAN form is only required if you are not bringing your own child and you wish to appoint a guardian in your place.
- 3.5. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the promoter, if such retention is approved by Motorcycling NSW.
- 3.6. Only entries received on the official entry form that are accompanied by the correct fee will be deemed an entry and accepted.



4. INSURANCE:

- 4.1. National Capital Benefits Scheme provides basic cover for death and permanent disability.
- 4.2. Personal Accident and Ambulance Insurance is the responsibility of the individual.
- 4.3. IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE DUE CONSIDERATION TO TAKING OUT SUCH INSURANCE COVER.

5. MEDICAL SERVICES:

- 5.1. Medical services will be available on both days from the beginning of competition through to the completion of the meeting.
- 5.2. Medical services will be provided by Emergency Australia.

6. <u>ENTRY FEE:</u>

6.1. Entry fees are:
\$70.00 for the 1st rider
\$60.00 for the 2nd rider
\$50.00 for any subsequent rider
50CC DEMONSTRATION \$40.00 per list

50CC DEMONSTRATION \$40.00 per rider (No 50cc demo entries accepted after 16th October 2015)

- 6.3. **Email Entry** (closes midnight Tuesday 20th October 2015):
- 6.4. Entry form and participant declaration forms should be fully completed and signed by both parent and rider, scanned and emailed to <u>racesecretary@yahoo.com</u>
- 6.5. NB: Smart phone or Tablet photos of entry forms are not acceptable and will not be accepted.
- 6.6. Entry fees must accompany the entry form.
- 6.7. EFT must be completed into the club bank account prior to submitting the entry form via email.
- 6.8. A separate entry form must be completed for each rider.
- 6.9. Payment by cash, cheque or electronic transfer only. Credit cards, EFTPOS or Pay Wave is not accepted.
- 6.10. Payment for late entries will be accepted on the day by cash only. ANY FEES FOR DISHONOURED CHEQUES WILL BE THE RESPONSIBILITY OF THE ENTRANT.
- 6.11. Cheques and Money Orders are to be made payable to the Blacktown Mini Bike Club.
- 6.12. Late entries after midnight Tuesday 20th October 2015 and entries on the day will incur a \$30.00 late fee per rider.
- 6.13. EFT Payments should be made into the following bank account:

- 6.14. Reference for EFT payments should be the rider surname and club initial and rider number MUST be included as a reference on the payment e.g. BT22 REED or BH22 23 24 REED NO reference = NO payment
- 6.15. NO EFT payments are to be made after midnight Tuesday 20th October closing date for entries. Any payments made after this date may not be received by the club prior to the event and will therefore not be recognised.

7. ENTRY PASSES:

Only officials and riders will be permitted in circuit and pit areas.

8. CLASSES OF COMPETITION:

Senior Combined 85/100cc 2-str or 150cc 4-str - A Grade Junior BW 85/100cc 2-str or 150cc 4-str – A B & C Grade 85cc 2-str or 150cc 4-str - A B & C Grade 65cc - A B & C Grade Mini Wheel - A B & C Grade 50cc Auto - A B & C Grade 50cc Demonstration (Non-competitive)

9. AWARDS AND PRIZEMONEY:

- 9.1. Placing 1st, 2nd & 3rd places in each grade will be awarded with a trophy.
- 9.2. All 50cc Demonstration Class entrants will receive a participation trophy.
- 9.3. Placings 1st, 2nd & 3rd in each event will be awarded an award (sash or medallion or similar).



10. ENTRIES TO CONSTITUTE A CLASS:

- 10.1. To constitute a class, the number of contestants entered and competing in each class shall be FOUR (4).
- 10.2. Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards and/or prize money, will be at the discretion of the promoter, subject to Motorcycling NSW approval.

11. RACE FORMAT:

11.1. The Events for this event over the two days are:

MINICROSS	LOOPING	RING RETURN	RING BENDING
FOOTING CLOVER	NON-FOOTING CLOVER	ACCEL-R8	SLOW
BENDING	ORANGE	ACCELERATE AND BRAKE	

- 11.2. If a runoff is necessary the event "Slow" will be run.
- 11.3. Heat finals will be run and scored as a heat. There will be no re-runs if all riders fault. Only riders successfully completing the course can place in the event.
- 11.4. Competitors amassing the highest overall points score will be the grade winners, 1st, 2nd & 3rd respectively.
- 11.5. In the event of a tie for 1st 2nd or 3rd place overall in any grade, the placing will be resolved by a run-off.
- 11.6. Any rider out of the correct grade will have points acquired up until that time deleted from their score.

11.7. IT IS THE RESPONSIBILITY OF THE RIDER TO BE IN THE CORRECT GRADE.

11.8. Results will remain "Provisional" until ratified and confirmed by Motorcycling NSW.

12. MACHINES AND RIDERS:

- 12.1. All machines entered must comply with the current GCR's for MINIKHANA competition.
- 12.2. Multiple entry of the one machine in the same class of competition is not permitted.
- 12.3. No change of machine is permitted. One rider, one bike or one bike, one rider.
- 12.4. Noise &/or Fuel Testing may be carried out at any time during this meeting.
- 12.5. All riders must wear their Club Vest or Jersey.

13. <u>RIDING NUMBERS:</u>

- 13.1. All number plates on all machines MUST comply with the GCR's.
- **13.2.** All bikes to be presented with correct coloured numbers and backgrounds on front and side plates of the bike according to the rider's grade.

"A GRADE" is black number on yellow background
"B GRADE" is white number on red background.
"C GRADE" is black number on white background
"SENIOR GRADE" is white number on black background
50CC Demonstration is white number on green background

14. GRID POSITIONS:

Lane position will be determined by a "draw of disks".

15. <u>RIDERS BRIEFING:</u>

A riders' briefing will be held prior to the commencement of practice and ALL participants MUST attend. Riders' briefing sign-on sheets must be signed by the participant as confirmation of attendance.

16. DRUG AND OR ALCOHOL TESTING:

By order of Motorcycling NSW, random drug &/or alcohol testing of participants (i.e. officials, competitors, mechanics, pit crew and any other person associated with the control, direction and operation of the competition) may take place prior to, or at any time during this meeting.

17. <u>CODE OF CONDUCT:</u>

All participants, officials and parents are reminded of the Motorcycling Australia - CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this meeting and shall be enforced.

18. <u>TIMETABLE:</u>

Meeting Commences:	7:00 am each day
Sign on/Scrutineering:	7:00 am to 8:30 am each day
Riders Briefing:	Immediately after sign on/scrutineering each day
Competition Starts:	Immediately after riders briefing each day
Competition End:	At completion of racing/events each day
Presentation:	At the completion of the meeting on Sunday

For the purposes of drug & alcohol testing, the commencement of the meeting will be deemed to be 7:00AM each day with the completion of the meeting for the participant being at the completion of racing.

19. CIRCUIT DESCRIPTION:

Clock-wise Minicross Track B (50cc and Mini wheels B & C grades) Anti-Clockwise Minicross Track A (65cc, 85cc, 150cc 4 stroke and mini wheels A grade)

20. <u>STARTS:</u>

- 20.1. Elastic stretch start Minicross
- 20.2. MX/SX PROCEDURE A 10 Second Board will be displayed to all riders. At the end of 10 seconds a 5 second board will be displayed. After a full 5 seconds, but not exceeding 10 seconds, the gates will drop.

21. <u>RACING:</u>

- 21.1. Sighting lap/laps will be conducted as per GCR.
- 21.2. There will be a minimum of two sighting laps.
- 21.3. Number of laps in heats and finals to be advised at Riders Briefing

22. <u>NOISE:</u>

All machines must comply with the requirements of the GCR's and the track licence.

23. PAYG WITHOUT HOLDING:

The Pay As You Go Tax affects the payment of prize money. If you do not provide an ABN or declare the sport is a hobby, the Promoter may withhold 47% of prize money over \$50.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize moneys paid to you.

24. SPECIAL NOTES AND WARNINGS:

- 24.1. **OPERATIONAL OFFICIALS & FLAG MARSHALS:** Parents or Guardians responsible for rider/s ARE required to assist in the running of events. NOTE: failure to do so may result in the exclusion of the rider from the meeting.
- 24.2. MACHINE EXAMINATION: All riders must present themselves fully dressed in riding attire with MA licenses and logbooks at sign on/scrutineering.
- 24.3. All bikes the suspension, frame, brakes, wheel size, handle bars (plugged), motor size must be as per original manufacturers specification for that particular bike frame.
- 24.4. Fuel or noise testing may be conducted at this meeting.
- 24.5. NO BIKES WILL BE RIDDEN OR STARTED IN THE CAR PARK.
- 24.6. NO PUSHBIKES ALLOWED ON THE VENUE.
- 24.7. Only one parent/guardian for demonstration class permitted inside fenced areas.
- 24.8. Anyone inside the fenced areas must be wearing a vest and must be signed on as a marshal or relevant official.
- 24.9. No rider or spectator is permitted on earth mounds.
- 24.10. Presentation will take place at the completion of all events and raffles.
- 24.11. There will not be any camping facilities on the premises.
